Confidentiality: All documents, data compilations, reports, computer programs, photographs, and any other work provided to or produced by Contractor in the performance of this Agreement shall be kept confidential by Contractor unless written permission is granted by Customer for its release or unless disclosure is otherwise required by law. Contractor shall have similar agreements with any subcontractor to maintain the confidentiality of information specifically designated as confidential by Customer.
