

BOARD OF COUNTY COMMISSIONERS
MINUTES OF PROCEEDINGS
April 18, 2023

The regular meeting of the Board of County Commissioners was brought to order at 5:34 p.m. by Chairman Steven Freel. Those in attendance were Commissioner Jim Milne, Commissioner Dallas Laird, Commissioner Dave North Commissioner Peter Nicolaysen, Acting County Attorney Charmaine Reed, County Clerk Tracy Good and Michelle Maines, Commissioners' Assistant.

Consent Agenda:

Commissioner Milne moved for approval of the Consent Agenda omitting item Resolution 10-23 for further discussion. Commissioner Nicolaysen seconded the motion. Motion carried.

Commissioner Nicolaysen moved to approved Resolution 10-23 with amendment to add \$34,000 for an equipment tractor for the NC Library. Make the corresponding amendment to the one cent priorities list. \$34,000 will be transferred from the Opportunity Fund. Commissioner North seconded the motion. Motion carried.

Public Hearings:

Commissioner Nicolaysen moved to approve the liquor license. Commissioner Milne seconded the motion. Motion failed.

Chairman Freel moved to table liquor license until the May 2, 2023 BOCC meeting to ensure restrictions can be placed on the liquor license, The restrictions concern the nature of the business associated with liquor and preventing the bar from being operated like Racks. Commissioner North seconded the motion. Motion carried.

Restrictions:

1. The liquor license can never become a part of a sexually oriented business.
2. Sonny Pilcher cannot have anything to do with the business financing, operation, or anything else.
