

**PETITION FOR FORMATION
IMPROVEMENT AND SERVICE DISTRICT**

Comes now the undersigned persons, acting pursuant to Wyoming Statute 22-29-105 and in conjunction with Wyoming Statute, Title 18, and Chapter 12; pertaining to the petition of formation for an improvement and service district, and represent as follows:

A petition to form a special district shall be signed by not less than sixty percent (60%) of the landowners owning at least sixty percent (60%) of the assessed valuation of property within the area proposed to be established as a special district in one (1) or more counties or any part of a county, as shown by the assessment records of the property in said area.
