



## NOTICE OF PRECINCT BOUNDARY CHANGE

In accordance with W.S. 22-7-102, the following changes in the lands described below are recommended:

**1-2- FROM** District/Precinct 2-2, **TO:** District/Precinct 1- 2: East side of S Poplar ST to south side of W Yellowstone HWY, to West side of S Walnut ST, to North side of W Collins DR.

**1-3- FROM:** District/Precinct 2-2, **TO:** District/Precinct 1-3: East side of S Poplar ST to South side of W Collins DR, to West side of S Cedar ST, to North side of CY AVE.

**1-4- FROM:** District/Precinct 1-11, **TO:** District/Precinct 1-4: East side of Yesness Park RD to South side of Lake RD, to West side of Casper Mountain RD, to North side of SE Wyoming BLVD.

**1-6- FROM:** District/Precinct 1-4 and District/Precinct 1-4.4, **TO:** District/Precinct 1-6 and District/Precinct 1-6.4: Southwest side of Allendale Blvd to North side of Galles DR, to East side of S McKinley ST, to North side of E 29<sup>TH</sup> ST, to East side of Bonnie Brae ST, to North side of E 27<sup>TH</sup> ST, to Eastern side of shared House District boundary of 56 and 35.

**1-7- FROM:** District/Precinct 3-4, **TO:** District/Precinct 1-7: West side of S Beverly ST to North side of E 21<sup>ST</sup> ST, to East side of S Conwell ST North to East 10<sup>th</sup> ST, to East of E 10<sup>th</sup> ST, to S Beverly ST.

**1-11- FROM:** District/Precinct 2-4, **TO:** District/Precinct 1-11: East side of S Poplar ST to South side of College DR, following House District boundary, and North of Nob Hill.

**1-12- FROM:** District/Precinct 3-2.2, **TO:** District/Precinct 1-12: South side of E 2<sup>ND</sup> ST to West side of S Beverly ST, to North side of E 4<sup>TH</sup> ST, to East side of S Kenwood ST.

**1-12- FROM:** District/Precinct 8-3, **TO:** District/Precinct 1-12: South side of E K ST to North of Barbara ST, to North of Helen ST, to North of Bernadine ST, to the West side of the Northern portion of Jane ST.

**2-6- FROM:** District/Precinct 1-9 and District/Precinct 1-9.3, **TO:** District/Precinct 2-6: South side of SW Wyoming Blvd to West side of S Poplar ST, to East side of Yesness Ln, to South side of W 50<sup>TH</sup> ST along City of Casper municipal boundary to North of W 50<sup>TH</sup>, to East of Chinook Trail RD along City of Casper municipal boundary, to Easterly of S Valley Rd within the City of Casper municipal boundary.

**2-6- FROM:** District/Precinct 2-3, **TO:** District/Precinct 2-6: South side of CY AVE to West side of Pheasant DR, to North side of Meadowlark DR, to North side of Outer RD, to West side of SW Wyoming BLVD.

**2-7- FROM:** District/Precinct 2-1, **TO:** Dist. 2 Prec. 7: East side of S Robertson RD to the North of Rivers Gate, to the East of River Park DR and North of the North Platte River.

**2-9- FROM:** District/Precinct 9-1, **TO:** District/Precinct 2-9: South side of Link DR within the City of Casper municipal boundary. East side of Paradise DR to South of City of Casper municipal boundary, to South of CY AVE within the City of Casper municipal boundary.

**3-4- FROM:** District/Precinct 1-6, **TO:** District/Precinct 3-4: South of Falcon Crest to the West of Red Tail ST, to East of S McKinley St, North to the South side of 21<sup>ST</sup> ST.

**3-6- FROM:** District/Precinct 1-6, **TO:** Dist. 3 Prec. 6: East side of S Beverly ST to South side of E 21<sup>ST</sup> ST, to East of Mercy LN, to South of E 26<sup>th</sup> ST within the City of Casper municipal boundary.

**3-6- FROM:** District/Precinct 3-8, **TO:** District/Precinct 3-6: East side of Missouri AVE to South side of E 10<sup>TH</sup> ST, to West side of Payne AVE, to South side of E 12<sup>TH</sup> ST, to West side of Kelly DR, to South side of E 15<sup>TH</sup> ST, to West side of Trojan DR, to West side of Kelly DR, to North side of E 18<sup>TH</sup> ST, to East side of Kingsbury DR, to North side of E 15<sup>TH</sup> ST.

**3-8- FROM:** District/Precinct 3-6, **TO:** District/Precinct 3-8: West side of Jasper DR to North side of E 21<sup>ST</sup> ST, to East side of S Missouri AVE.

**3-9- FROM:** District/Precinct 3-10, **TO:** District/Precinct 3-9: East side of SE Wyoming Blvd to North side of Blackmore Rd within City of Casper municipal boundary.

**4-1- FROM:** District/Precinct 4-2, **TO:** District/Precinct 4-1: South side of E Yellowstone HWY to North of I-25 along Evansville Town boundary and described in Evansville Town Ordinance 7-2021.

**4-2- FROM** District/Precinct 12-2 **TO:** District/Precinct 4-2: East of shared House District boundary of HD 35 and HD 62 to North of shared House District boundary of HD 37 and HD 62.

**8-1- FROM:** District/Precinct 8-2, **TO:** District/Precinct 8-1: North of West Belt Loop, to East side of N Robertson RD, to South side of Zero RD, to South side of W Yellowstone HWY and described in City of Mills Ordinance 770.

**8-1.2- FROM:** District/Precinct 8-4, **TO:** District/Precinct 8-1.2: West side of N Robertson RD along Southern boundary of Zero Road Industrial Park Subdivision, to Western boundary of Zero Road Industrial Park Subdivision, to South side of Zero RD.

**8-4- FROM:** District/Precinct 2-8.4, **TO:** District/Precinct 8-4: South of Poison Spider RD to the Western municipal boundary of the City of Mills, to the Southern municipal boundary of the City of Mills, to the West side of S Robertson RD, to the North side of Squash Blossom RD, North of natural drainage following the HD58/HD 38 boundary .

**9-1- FROM:** District/Precinct 1-9.4 **TO:** District/Precinct 9-1: East of S Valley RD and West of Chinook Trail RD outside the City of Casper municipal boundary.

**12-2- FROM:** District/Precinct 4-2, **TO:** District/Precinct 12-2 South of shared House District boundary HD 37 and HD 62 to West of shared House District boundary of HD 37 and HD 62.

These changes will be published for two (2) consecutive weeks prior to finalization in formal action by the Board of County Commissioners at the regular meeting on April 19, 2022. These changes shall be effective for the elections during the year 2022.
